Health

• Occupational Health:

We implement structured health surveillance programmes, including pre-employment and periodic medical assessments, ergonomic evaluations, and audiometric and respiratory function tests. These initiatives ensure our workforce remains healthy, fit for duty, and supported across their entire employee lifecycle.

• Wellness & Preventive Care:

We proactively promote employee wellness through integrated health campaigns, including biometric screenings, stress management sessions, nutrition and fitness education, and digital access to health experts. We believe in not just preventing illness but empowering employees to live healthier lives.

• Medical Emergency Preparedness:

Every SEEPCO site is equipped with modern medical infrastructure, including trained emergency responders, first-aid stations, and AEDs. Emergency response plans are routinely tested with multi-scenario drills to ensure preparedness and rapid intervention capabilities.

• Pandemic Preparedness and Response:

In light of global health challenges, SEEPCO has developed robust pandemic response plans. These include protocols for remote work, health screenings, provision of personal protective equipment (PPE), and vaccination drives to protect our workforce and maintain business continuity. These measures are regularly updated based on guidance from international and national health authorities.

Security

SEEPCO recognises that strong security management is essential for safe and uninterrupted operations. Our integrated security approach ensures business continuity, employee safety, and asset protection.

• Risk Intelligence & Mitigation:

We apply a risk-based approach to security that incorporates geospatial mapping, community intelligence, and predictive analytics to mitigate emerging threats. Regular threat assessments guide customised security strategies across sites.

• Integrated Technologies:

Our facilities are protected with layered security, including biometric access systems, high-resolution CCTV surveillance, motion detectors, and geofencing. Cybersecurity protocols ensure robust protection of our digital infrastructure.

• Stakeholder Collaboration:

We work closely with law enforcement agencies, host communities, and private security partners to create secure operational environments. Our community liaison model ensures mutual understanding and shared responsibility.

• Awareness & Training:

All personnel undergo extensive security training, including travel risk awareness, conflict de-escalation, digital safety, and site-specific emergency protocols. We also simulate realistic scenarios to reinforce readiness and vigilance. At SEEPCO, safety is not only a value – it is embedded into everything we do. Our vision is to maintain a zero-harm workplace by instilling a safety-first mindset and robust operational controls.

• Process Safety:

We apply global safety tools such as HAZOP, SIL, and Bowtie Analysis to identify and manage high-consequence risks. All assets undergo risk quantification and barrier verification to ensure safe operation throughout their lifecycle.

• Behavior-Based Safety (BBS):

We foster a proactive safety culture where every employee is empowered to act. Our programmes include peer observations, safety coaching, safety dialogues, and stopwork authority to address unsafe conditions before they escalate.

• Incident Management:

We have deployed a digital incident reporting platform to streamline data collection, root cause analysis, and corrective actions. Lessons learnt are translated into practice through site-wide communications and retraining where necessary.

• Contractor Safety:

All contractors undergo rigorous prequalification, onboarding, and training aligned with SEEPCO's safety standards. Regular joint audits and safety workshops ensure alignment and continuous improvement.

• International Standards Compliance:

SEEPCO's safety framework is aligned with ISO 45001:2018, promoting a structured and continuous improvement approach to hazard identification, risk mitigation, and worker participation.

Environment

Environmental responsibility is a core pillar of SEEPCO's operational philosophy. We are dedicated to minimising our environmental footprint through innovation, efficiency, and stewardship. SEEPCO views environmental protection not just as compliance but as an ethical imperative to future generations. We go beyond regulatory requirements to integrate sustainability into daily operations.

• Carbon & Emissions Management:

We leverage energy efficiency, flare reduction, and emissions tracking to reduce our carbon footprint. Real-time monitoring systems are deployed to manage emissions, and pilot programs are underway for carbon capture and alternative energy integration.

• Waste & Resource Management:

Our waste management system emphasises segregation, reduction, reuse, and safe disposal. Hazardous and non-hazardous waste streams are tracked and audited. We collaborate with licensed vendors to promote circular economy practices.

• Water Stewardship:

SEEPCO is committed to efficient water usage, with strategies such as zero-discharge systems, stormwater harvesting, and water recycling facilities. Discharges are regularly tested to meet or exceed environmental standards.

• Biodiversity Protection:

Fire

Fire prevention and response are strategically managed to safeguard life, assets, and continuity of operations. SEEPCO maintains a fire risk management framework aligned with NFPA codes and ISO 45001 standards.

• Fire Risk Assessment:

We conduct structured fire risk assessments across facilities using industry frameworks. This includes identifying ignition sources, assessing fire loads, reviewing escape routes, and evaluating response capacity.

• Prevention & Detection Systems:

Fire detection and suppression technologies including flame and heat sensors, foam systems, gas-based extinguishers, and automatic alarms are integrated across operational zones. Passive protection such as fireproof coatings and compartmentalisation is also implemented.

• Fire Response Capability:

SEEPCO maintains well-trained Emergency Response Teams with access to modern firefighting equipment, including fire tenders, PPE, and fixed extinguishing systems. Our teams perform routine fire drills and joint exercises with external responders.

• Design & Compliance:

Fire safety is incorporated into engineering design per NFPA codes and ISO 45001. All fire safety systems are subject to regular audits and recertification.

Community Awareness:

Community engagement initiatives include open forums, evacuation drills, and educational programs on fire safety. These efforts build community preparedness and foster trust.

Social Performance

Our social performance strategy focuses on creating shared value, empowering communities, and operating with respect and inclusivity.
